AN APPROPRIATION ORDINANCE RE-ALIGNING THE SUM OF P369,876.84 REPRESENTING SAVINGS FROM THE VACANT AND UNFILLED ITEMS UNDER THE EXECUTIVE DEPARTMENT, TO BE USED FOR THE PERSONAL SERVICES OF THE ADDITIONAL 2 REGULAR SEATS IN THE SANGGUNIANG PANLUNGSOD FOR THE PERIOD FROM OCTOBER TO DECEMBER 2012.

WHEREAS, the City of Ilagan has acquired its corporate existence upon the ratification of its creation by Republic Act No. 10169, by a majority of the votes cast by the qualified voters in a plebiscite conducted last August 11, 2012;

WHEREAS, Republic Act 10169 or the City Charter of Ilagan specifically, Section 10(a), Article IV, provides that "The Sangguniang Panlungsod, the Legislative Body of the City, shall be composed of the City Vice Mayor as the Presiding Officer, the ten (10) Regular Sanggunian Members, the President of the City Chapter of the Liga ng mga Barangay, the President of the Panlungsod na Pederasyon ng mga Sangguniang Kabataan and the three (3) Sectoral Representatives, as members xxx"

WHEREAS, the present membership composition of the Sangguniang Panlungsod is eight (8) regular members, the Liga ng mga Barangay President, the SK Federation President and the three (3) Sectoral Representatives

WHEREAS, this August Body deems it imperative to complete the membership of the Sanggunian to ten membership, and to provide for the funding requirements for the two (2) additional regular seats, to be sourced out from the appropriations of unfilled positions in the plantilla of the Executive Department;

NOW, THEREFORE,

Be it ordained by the City Council of Ilagan in its Special Session assembled, that:

Section 1. The sum of P369,876.84 representing savings from vacant and unfilled positions under the Executive Department is hereby re-aligned and appropriated, as follows:
