



City Appropriation Ordinance 004-2013

AN ORDINANCE AUTHORIZING THE ANNUAL GENERAL FUND BUDGET OF THE CITY GOVERNMENT OF ILAGAN AND THE OPERATION OF ECONOMIC ENTERPRISE FOR FISCAL YEAR 2014 IN THE SUM OF P1,084,804,341.00 COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT FOR FISCAL YEAR 2014, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

Be it ordained by the Sangguniang Panlungsod of Ilagan in its Regular Session assembled, that:

Section 1. The Annual General Fund Budget of the City Government of Ilagan for Fiscal Year 2014 and the operation of its Economic Enterprise in the total amount of **ONE BILLION 84 MILLION EIGHT HUNDRED FOUR THOUSAND AND THREE HUNDRED FORTY ONE PESOS (P1,084,804,341.00)** covering the various expenditures for the operation of the City Government for the year 2014 is hereby approved.




Section 6. This appropriation ordinance shall take effect on January 1, 2014.
