AN ORDINANCE APPROVING THE APPROPRIATION OF THE SUM OF P204,539.94 REPRESENTING SAVINGS FROM THE PERSONAL SERVICES OF 1 ADMINISTRATIVE OFFICER IV SG 15/4 UNDER THE OFFICE OF THE SANGGUNIANG PANLUNGSOD COVERING THE PERIOD FROM MAY 1, 2014 TO DECEMBER 31, 2014, WHICH HAS BEEN DECLARED VACANT IN VIEW OF THE PROMOTION OF THE INCUMBENT EMPLOYEE, TO BE USED FOR THE PERSONAL SERVICES OF VARIOUS PLANTILLA ITEMS CREATED BY VIRTUE OF SPECIAL ORDINANCE NO. 010-2014.

WHEREAS, in view of the creation of various plantilla positions under the Legislative Department of the City Government of Ilagan by virtue of Special Ordinance No. 010-2014 dated October 21, 2014, this August Body deems it imperative to provide for the funding requirement for its Personal Services from November 1, 2014 to December 31, 2014 in the sum of P 204,539.94;

WHEREAS, the source of fund shall come from the savings of the Personal Services of 1 Administrative Officer IV SGH 15/4 for the period May to December 2014;

NOW, THEREFORE

Be it ordained by the City Council of Ilagan in its Regular Session assembled, that:

Section 1. The sum of 204,539.94 representing the savings of the Personal Services of 1 Administrative Officer IV SG 15/4 under the Legislative Department from May to December 2014, is hereby appropriated for the Personal Services of various plantilla positions created by virtue of Special Ordinance No. 010-2014, as follows:
