AN ORDINANCE APPROVING THE AUGMENTATION/REPROGRAMMING OF FUNDS UNDER THE 20% ECONOMIC DEVELOPMENT FUND IN THE SUM OF P14,592,700.00 TO BE USED FOR VARIOUS INFRASTRUCTURE PROJECTS IN THE CITY OF ILAGAN.

WHEREAS, presented for consideration of this August Body is the request of the Honorable Mayor Josemarie L. 
Section 2. This appropriation ordinance shall take effect upon its approval.
