Appropriation Ordinance 001-2021

AN ORDINANCE APPROVING THE REPROGRAMMING OF THE PORTION OF THE 20% ECONOMIC DEVELOPMENT FUND OF THIRTY MILLION PESOS (P30,000,000.00) AND APPROPRIATING THE SAME FOR THE AMORTIZATION OF VARIOUS DEVELOPMENT PROJECTS OF THE CITY OF ILAGAN.

BE IT ORDAINED by the Sangguniang Panlungsod of Ilagan in its Regular Session assembled, that:

Section 1. A portion of the 20% Economic Development Fund of Thirty Million Pesos (P30,000,000.00) is hereby reprogrammed and appropriated for the amortization of various development projects of the City of Ilagan.


Section 4. Effectivity. The provisions of this Ordinance shall take effect immediately upon its approval.




