AN ORDINANCE APPROVING THE REPROGRAMMING OF A PORTION OF THE PROCEEDS FROM LOAN BORROWINGS AMOUNTING TO FIFTY MILLION PESOS (P50,000,000.00) AND APPROPRIATING THE SAME FOR THE PURCHASE OF VARIOUS LOTS LOCATED AT MARANA 1<sup>ST</sup>, LULLUTAN, AND ALIBAGU, CITY OF ILAGAN, ISABELA, LISTED IN THE ANNUAL INVESTMENT PLAN FOR 2024.

BE IT ORDAINED by the Sangguniang Panlungsod of Ilagan in its Regular Session assembled, that:

**Section 1.** A portion of the proceeds from Loan Borrowings amounting to Fifty Million Pesos (P50,000,000.00) intended for the construction of Cold Storage as indicated in Special Ordinance No. 016-2023 enacted by this August Body is hereby reprogrammed and appropriated for the purchase of various lots located at Marana 1<sup>st</sup>, Lullutan, and Alibagu, City of Ilagan, Isabela as listed in the Annual Investment Plan for 2024.

**Section 2. Source of Fund.** The reprogramming of a portion of the proceeds from loan borrowings of the City of Ilagan sourced from the following projects is hereby approved:

**Section 4. Effectivity.** The provisions of this Special Ordinance shall take effect immediately upon its approval.


