AN ORDINANCE APPROVING THE REPROGRAMMING OF A PORTION OF THE 2025 ECONOMIC DEVELOPMENT FUND AMOUNTING TO THIRTEEN MILLION PESOS (P13,000,000.00) AND APPROPRIATING THE SAME FOR THE RENOVATION OF THE SAN ANTONIO CITY OF ILAGAN HOSPITAL.

BE IT ORDAINED by the Sangguniang Panlungsod of Ilagan in its Regular Session assembled, that:

Section 1. A portion of the 20% Economic Development Fund for Fiscal Year 2025 amounting to Thirteen Million Pesos (P13,000,000.00) intended for the construction of Dialysis Center at City of Ilagan Medical Center and Construction of Clinical Laboratory at San Antonio City of Ilagan Hospital is hereby reprogrammed and appropriated for the completion of various works for completion of San Antonio City of Ilagan Hospital.

Section 2. Source of Fund. The reprogramming of a portion of the 20% Economic Development Fund for Fiscal Year 2025, sourced from the following projects, is hereby approved:

• Construction of Dialysis Center at CIMC	5,000,000.00
• Construction of Clinical Laboratory at SACIH	8,000,000.00

Section 3. Use of Funds. The appropriation of **THIRTEEN MILLION PESOS (P13,000,000.00)** for various works for the renovation of San Antonio City of Ilagan Hospital is hereby approved, as follows:

• Renovation of Emergency and Medical Offices	3,911,627.98
• Electrical Service Entrance Wire and Panel Boards	721,447.07
TOTAL P	13,000,000.00

Section 4. Effectivity. The provisions of this Special Ordinance shall take effect immediately upon its approval.

To: San Antonio City of Ilagan Hospital (SACIH)


- Fabrication of Steel Frames, Installation of Aluminum Cladding, and Signages - Php 2,570,985.60

- Electrical Service Entrance Wire and Panel Boards (Old Building) Php 721,447.07


