



Tax Ordinance 006-2016

AN ORDINANCE IMPOSING THE COLLECTION OF ENVIRONMENTAL FEE AND REGISTRATION FEE IN THE JAPANESE TUNNEL LOCATED AT BARANGAY STO. TOMAS, CITY OF ILAGAN, ISABELA.

WHEREAS, the City Government of Ilagan has discovered a Japanese Tunnel in Barangay Sto. Tomas, City of Ilagan, Isabela, which has been developed and its historical and cultural values preserved for the enjoyment of the present and future generations;

WHEREAS, in consonance with the objective of the National Government, the City Government of Ilagan identifies sustainable tourism development as integral to the national socio-economic development efforts to improve the quality of life of the Ilagueños while preserving the history of the City;

WHEREAS, this August Body deems it imperative to prescribe fees in the entry to the Japanese Tunnel for its preservation, maintenance and operation;

NOW, THEREFORE

Be it ordained by the City Council of Ilagan in its Regular Session assembled, that:

Section 1. The following fees shall be collected in the entry to the Japanese Tunnel, as follows:

- a. There shall be collected a Registration Fee of Twenty-Five (P25.00) Pesos; and Environmental Fee of Five (P5.00) Pesos for every person entering the Japanese Tunnel.
- b. Pre-school children shall pay a discounted rate of Registration Fee of Fifteen (P15.00) Pesos; and Environmental Fee of Five (P5.00) Pesos; provided they shall present valid identification documents.
- c. Discounted Rate of twenty percent (20%) off to the total amount shall apply to Persons with Disability (PWDs) and Senior Citizens (SCs), under Republic Act No. 9442 and Republic Act No. 10645, respectively, provided that they shall present valid identification documents proving their membership.
- d. Discounted rate of ten percent (10%) off to the total amount shall apply to Solo Parents, under Republic Act No. 8972, provided that they shall present valid identification documents proving their membership.
- e. Said fees shall be paid to the personnel of the City Treasurer's Office at the main entrance of the Japanese Tunnel and shall accrue to the funds of the City Government for the purposes it is stated.


OPENING PROMO:

As opening promo, the fees collected shall be P20.00 per person on February 16, 2016 only.

Section 2. Effectivity. This Ordinance shall take effect after 15 days following its publication in a newspaper of general circulation in the locality.




