**WHEREAS**, in the desire of the present administration to further promote eco-tourism in the City of Ilagan, it has installed added amenities and facilities at the Ilagan Sanctuary to entice more tourist to visit the area, as follows:

1. High Rope Obstacle
2. Zip Bike
3. Paint Ball
4. Biking

**WHEREAS**, in view hereof, and to assure the provision of better services and ensure proper maintenance of these facilities and amenities, this August Body deems it necessary and prudent to impose the collection of fees in the use of the added amenities and facilities at the Ilagan Sanctuary

**NOW, THEREFORE**

**Be it ordained** by the City Council of Ilagan in its Regular Session assembled, that:

**Section 1.** That the following fees shall be imposed and collected in the use of the following added amenities and facilities at the Ilagan Sanctuary, to wit:

**Section 2. Effectivity.** This Ordinance shall take effect after 15 days following its publication in a newspaper of general circulation in the locality.



