AN ORDINANCE AMENDING IN ITS ENTIRETY, CITY TAX ORDINANCE NO. 006-2016.

WHEREAS, sometime in January 26, 2016, this August Body has enacted Tax Ordinance No. 006-2016, imposing the collection of environmental fee and registration fee at the Japanese Tunnel;

WHEREAS, this August Body deems it necessary to amend the said ordinance in its entirety to correspond to the improvements and development done in the site;

NOW, THEREFORE

Be it ordained by the City Council of Ilagan in its Regular Session assembled, that:

Section 1. The title of the Ordinance shall be **AN ORDINANCE IMPOSING THE COLLECTION OF FEES AT THE JAPANESE TUNNEL LOCATED AT BARANGAY STO. TOMAS, CITY OF ILAGAN, ISABELA.**

Section 2. The following fees shall be collected in the entry to the Japanese Tunnel, as follows:


Section 5. Effectivity. This Ordinance shall take effect after 15 days following its publication in a newspaper of general circulation in the locality.


