Tax Ordinance 014-2020  
June 22, 2020

AN ORDINANCE IMPOSING THE PAYMENT OF SECURITY STICKER FEE OF FIFTY PESOS (50.00) PER CIVIL REGISTRY DOCUMENT ISSUED BY THE CITY CIVIL REGISTRAR'S OFFICE.

**WHEREAS**, pursuant to Ease of Doing Business, also known as R.A. 1103, the state shall ensure the adoption of simplified requirements and procedures that will reduce red tape and expedite business and nonbusiness related transactions in government;

**WHEREAS**, the stamping of Security Sticker on all issued local certificates of birth, marriage and death will strengthen the authenticity of these documents and it will simplify and expedite all transactions in other offices or agencies needing these documents;

**WHEREAS**, Section 16 of the Local Government Code of 1991 mandates local government units to exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, this August Body perceives the need to strengthen the integrity of local certificates for birth, marriage and death issued by the Office of City Civil Registrar;

**WHEREAS**, to carry out this objective, it is imperative that all local certificates for birth, marriage and death issued by the City Civil Registrar should come with a security sticker;

**WHEREAS**, the estimated cost per security sticker is more or less Fifty Pesos (P50.00);

**NOW, THEREFORE**

**BE IT ORDAINED** by the Sangguniang Panlungsod of the City of Ilagan in its Regular Session assembled, that:

**Section 1. Title.** This Ordinance shall be known as Tax Ordinance 014-2020, or to be otherwise known as the Local Civil Registry Documents Sticker Fee Ordinance".

**Section 2. Scope.** The imposition of Security Sticker Fee shall apply to all local birth, marriage and death certificates issued by the City Civil Registrar's Office.

**Section 3. Payment of Fees.** The payment of Security Sticker Fee of P50.00 per Civil Registry Document issued by the City Civil Registrar's Office is hereby imposed.


**Section 4. Repealing Clause.** All existing laws, ordinances, or rules and regulations contrary to the provision of this Ordinance are hereby repealed or amended accordingly.


