Tax Ordinance 015-2020

July 6, 2020

AN ORDINANCE AMENDING ARTICLE B (a) SECTION 194 OF THE REVENUE CODE OF THE CITY OF ILAGAN, TO LOWER THE PARKING RATES PRESCRIBED IN CITY-OWNED PARKING AREAS OR DESIGNATED STREETS FOR PAY PARKING DURING THE PERIOD FROM JULY 2020 TO AUGUST 31, 2020.

WHEREAS, sometime in May 11, 2020, this August Body passed Resolution No. 146, allowing the use of the Ilagan Central Terminal and the Parking Area at the Baligatan Public Market free of charge during the duration of the General Community Quarantine Period as terminal for the Ilagan Tricycle Operators and Drivers Association (TODA);

WHEREAS, this move is to support the transport group who were gravely affected by the lockdown to recover from their financial losses;

WHEREAS, now that the City of Ilagan is one among those areas declared to be under Modified General Community Quarantine, the transport group have started to pull through and their economic situation is starting to stabilize;

WHEREAS, this August Body believes that requiring this transport group to pay their parking dues again at 50% lesser than what was imposed in the Revenue Code will not be a burden to them;

NOW, THEREFORE

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Ilagan in its Regular Session assembled, that:

Section 1. Title. This Ordinance shall be known as Tax Ordinance 015-2020, or to be otherwise known as "Amendatory Ordinance to Article B(a) Section 194 of the Revenue Code".

Section 2. Amendment. Article B(a) Section 194 of the Revenue Code is hereby amended, as follows:

"Section 194. Imposition of Fees. There shall be collected fees for the use of the City owned parking areas or designated streets for pay parking in accordance with the following schedule:

a. Pay Parking Rates	
Tricycle	P10.00
Private Cars and Service Vehicles	20.00
Service Vehicles of Stall Owners	25.00
Passenger Jeepneys	20.00
Cargo Trucks/Delivery Vans	50.00
Passenger Bus	40.00

Section 3. Duration. The amendment in the parking rates prescribed in this amendatory ordinance shall be for the period from July 2020 to August 31, 2020 only.


**Section 5. Separability Clause.** If, for any reason, any part or provision of this Ordinance shall be held unconstitutional or invalid by a competent Court, other parts or provisions hereof, which are not affected thereby, shall continue to be in full force and effect.

**Section 6. Repealing Clause.** All existing laws, ordinances, or rules and regulations contrary to the provision of this Ordinance are hereby repealed or amended accordingly.


**Section 5. Effectivity.** This Ordinance shall take effect immediately after fifteen (15) days following its publication in a newspaper of general circulation in the locality.
