Tax Ordinance 023-2022
December 5, 2022

AN ORDINANCE PRESCRIBING THE COMPUTERIZED TOMOGRAPHY SCAN (CT SCAN) RATES AND CHARGES IN THE CITY OF ILAGAN MEDICAL CENTER (CIMC).

WHEREAS, the City Government of Ilagan, resolute in attaining social improvements and better quality of life for its inhabitants, established the City of Ilagan Medical Center to ensure the provision of holistic, efficient, affordable, and accessible health services;

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates Local Government Units to exercise the power expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Republic Act 7160 likewise authorizes Local Government Units to create their own sources of revenues to defray the expenses of government operations and impose and collect such reasonable fees and charges for services rendered;

WHEREAS, the CIMC is an economic enterprise fully owned and operated by the City Government of Ilagan, duly accredited by the Department of Health;

WHEREAS, the services of the CIMC expanded to providing Computerized Tomography Scan (CT Scan) services and it is incumbent upon this August Body to determine the corresponding fees that shall be imposed for the services of the CIMC pursuant to Article III, Section 458 (2)(ii) of the Local Government Code;

NOW, THEREFORE,

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Ilagan in its Regular Session assembled, that:

Section 1. Title. This Ordinance shall be known as Tax Ordinance 023-2022, otherwise known as "CIMC CT Scan Rates."

Section 2. Statement of Policy. It is hereby declared the policy of the City Government of Ilagan to impose uniform rates for the services of the CIMC incidental for its operation and maintenance, taking into consideration the primary intent to provide affordable and quality medical services.

Section 3. Service Fees for CT Scan. The corresponding rates/fees for CT Scan services provided by the CIMC are as follows:

* **Excluded from the rates: Use of Power Injector/Syringe.** Additional charge of P 2,500.00 (Two Thousand Five Hundred Pesos) shall be collected for the use of Power Injector/Syringe.

Section 4. Reader's Fee. The reader's fee is included in the fees to be collected, representing 25% of the total fees based on Plain CT Scan Rates. In cases of emergency procedure, an additional fee of P1,000.00 (One Thousand Pesos) shall be charged for Radiologist-on-call.

Section 5. Enforcement. The Medical Director of the City of Ilagan Medical Center is directed to implement and enforce this ordinance. Accordingly, the CIMC Medical Director shall recommend to the City Mayor the necessary adjustments on the fees herein provided based on the prevailing market prices of consumables and other supplies.

The Sangguniang Panlungsod shall evaluate and adopt as an amendment to this ordinance any adjustments on the fees imposed for the services rendered based on the recommendation of the City Mayor.

Section 5. Separability Clause. If for any reason, any part or provision of this Ordinance shall be held unconstitutional or invalid by a competent Court, other parts or provisions hereof, which are not affected thereby, shall continue to be in full force and effect.

Section 6. Repealing Clause. All existing laws, ordinances, or rules and regulations contrary to the provision of this Ordinance are hereby repealed or amended accordingly.


Section 5. Effectivity. This Ordinance shall take effect immediately after fifteen (15) days following its publication in a newspaper of general circulation in the locality.


