AN ORDINANCE APPROVING THE PRESCRIBING FEES AT THE ILAGAN SANCTUARY.

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates Local Government Units to exercise the power expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Republic Act 7160 likewise authorizes Local Government Units to create their own sources of revenues to defray the expenses of government operations and impose and collect such reasonable fees and charges for services rendered;

WHEREAS, the City Government of Ilagan in partnership with the Department of Environment and Natural Resources – Protected Area Management Board (DENR-PAMB) developed the 240 hectares ILAGAN Sanctuary through a Memorandum of Agreement for the purpose of generating funds for the rehabilitation and protection of the forest area;

WHEREAS, it is incumbent upon this August Body to determine the corresponding fees that shall be collected in ILAGAN Sanctuary pursuant to Article III, Section 458 (2)(ii) of the Local Government Code;

NOW, THEREFORE

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Ilagan in its Regular Session assembled, that:

Section 1. Title. This Ordinance shall be known as Tax Ordinance 025-2023, otherwise known as "ILAGAN Sanctuary Fees."

Section 2. Statement of Policy. It is hereby declared the policy of the City Government of Ilagan to impose fair rates incidental to the operation and maintenance of the ILAGAN Sanctuary, taking into consideration the primary intent to manage, develop, protect, and rehabilitate the same and generate funds for the protection of the forest area.

Section 3. Entrance Fees. The entrance fee shall be inclusive of the use and access of the swimming pools, tree top adventure, animal kingdom, children's playground, Serenity Hill (prayer mountain), caves, and Pinzall falls, as follows:

Section 4. Rental Fees. Use of function halls for events and rent of gazebo shall be exclusive of entrance fees, and shall be charged as follows:

Section 9. Administrative Provisions. The Office of the City Mayor, through the concerned Department and personnel assigned for the management and operation of the ILAGAN Sanctuary, shall enforce the provisions of this Ordinance.

Section 10. Separability Clause. If for any reason, any part or provision of this Ordinance shall be held unconstitutional or invalid by a competent Court, other parts or provisions hereof, which are not affected thereby, shall continue to be in full force and effect.

Section 11. Repealing Clause. All existing laws, ordinances, or rules and regulations contrary to the provision of this Ordinance are hereby repealed or amended accordingly.

Section 12. Effectivity. This Ordinance shall take effect fifteen (15) days following its publication in a newspaper of general circulation in the locality.
